The New Zealand Choral Federation represents around 21,000 singers and conductors drawn from 550 choirs all over New Zealand. As well as mounting choral events for singers, we provide resources and training for conductors, inspiring and sustaining them with educational opportunities, support, mentoring and online resources. Annual membership subscriptions are now due and should be paid by **1 April 2019** in order to remain current. Conductors taking part in The Big Sing or The Kids Sing this year are entitled to free membership of ACD for 2019, although they do need to fill out a registration form.
